# Barbara Bush Helps Maine Medical Center Celebrate the Groundbreaking for New Facilities at its Bramhall Campus

On September 14, Barbara Bush helped Maine Medical Center mark the start of an exciting expansion project that will help us meet the growing needs of our local community. Mrs. Bush was introduced at the event by her husband, President George H.W. Bush.

"To every volunteer in the hospital, to every doctor, to every nurse, let me simply say how great the respect is that Barbara and I, our whole family, have for the work you do, day in and day out," said President Bush. "It's unbelievable."

"Truly for me, one of the best things to happen was the great honor you gave me when you put my name on your children's hospital," said Mrs. Bush. "The doctors and nurses, the staff members and volunteers, and everyone in our community who support the hospital – all of you who have made this such a special place - you make me so proud every single day to be a part of your team. I really cannot go anywhere without someone coming up to me and thanking me for the great work that YOU do."

The groundbreaking for the Charles Street Project will

include a new women and infants building, a parking garage, a helipad, improved access and wayfinding, and a central utility plant. It also encompasses the renewal of facilities for intermediate care and routine and critical care patient services. MMC will also renovate and expand the existing Emergency Department. The project is being done to accommodate the growing healthcare needs of the Portland community, as well as the rest of the state.

At the event, Vincent S.
Conti, President and Chief
Executive Officer of MMC,
thanked those who have played
crucial roles in the fundraising
and planning efforts for these
projects: leadership donors, our
Congressional delegation, State
and City officials, and
caregivers. He also thanked
Mrs. Bush for her leadership as
the honorary chair of MMC's
Capital Campaign, which
continues to seek support for
these vital projects.

"As I reflect about what today really represents," he said, "I think it's important to

# MMC Employees Step Up to Aid in Hurricane Relief

Employees from Maine Medical Center are helping victims of Hurricane Katrina in more ways than one.

Maria Cushing, a certified nursing assistant (CNA) on R4, was among four MMC CNAs who left earlier this month to work at a temporary medical facility an hour from New Orleans. Cushing helped doctors and nurses, take vital signs, and comfort people displaced since Hurricane Katrina hit early in September.

"It is so hard just to watch," said Cushing as she prepared to board an early morning flight at Portland International Jetport. "I feel somebody needs to do something. That we need to help."

Once in Louisiana, the MMC contingent—Cushing; Joseph Makonnen, P6; Jenny Howitt, Employee Health; and Michael McKay, Brighton FirstCare—joined other CNA volunteers from Maine who traveled on separate flights that same day from Eastern Maine Medical Center in Bangor, Knox Center for Long-term Care in Rockland, and Goodall Hospital in Sanford. The group was the first major

# MMC Receives State Approval for New Outpatient Surgery Center

Maine Medical Center received state approval this month to build a \$25 million outpatient surgery center on its Scarborough Campus.

The project, with 10 operating rooms and a six-bed unit for overnight stays, will help MMC meet the increasing demand for surgical services. It will also promote efficiency by consolidating outpatient surgery now performed at the Bramhall and Brighton campuses. Maine Medical Center expects to break ground on the site either in the fall or spring, with construction taking about 18 months.

"This is very good news for our patients and for the surgeons who do their work at Maine Medical Center," says Vincent S. Conti, MMC President and CEO. "We started this project because our operating rooms are running at capacity, and the need for surgical services at MMC continues to rise with no end in sight. We are responding to the needs of people who want to have their care here. And we're responding to surgeons who are acutely aware that we need more capacity. The Scarborough ASC is the most cost-effective way to do that. Further delay in starting this project will only exacerbate the frustration being experienced by our patients, our staff, and our surgeons. We're grateful that the Commissioner has given due consideration to the objections that have been raised, and that in the end he made the correct decision for the people of Maine."

Maine Medical Center developed a proposal to consolidate outpatient surgeries in part because current operating rooms are at more than 90 percent capacity. This reflects a 33 percent increase in surgical cases from 1996 to 2003.

The project will increase the number of operating rooms from 26 to 31. Moving the bulk of day surgeries to Scarborough will also create availability at the Bramhall Campus for complex inpatient surgeries, as well as reduce the delays and cancellations experienced when emergencies disrupt the operating room schedule. Further, space at the Brighton campus will be freed up for endoscopic exams, which involve viewing the inside of a body cavity using fiber optics.

Due to the size and scope of the proposed project, Maine Medical Center had to submit an application for approval through the state's Certificate of Need process. MMC received approval in late September.

The proposed 40,000-square-foot center would sit toward the back of the 50-acre campus, away from Route 1. The project is awaiting permits from the state Department of Environmental Protection and the town of Scarborough.

respond if needed.

"We have had more than 250 employees indicate a willingness to volunteer," says Jason Elliott, Associate Vice President, Human Resources. "At this point, we have not had any further requests for assistance from the Maine Emergency Management Agency (MEMA). If the call comes, however, we will be ready to answer."

Makonnen said he's happy to be able to go there and help the hurricane victims. "After watching the news like everybody else, I felt heartbroken."

The volunteers who traveled to assist with the hurricane relief efforts will continue to receive their regular salaries from Maine Medical Center. The hospital also made sure those employees had updated shots for tetanus and Hepatitis B.

David Kissin, respiratory therapist, Pulmonary Medicine, is currently participating in his second Hurricane Katrina relief mission in the Gulf states as part of a Disaster Medical Assistance Team within the Federal Emergency Management Agency. Along with other MMC medical specialists who are part of the Disaster Team, Kissin spent his first trip in Biloxi and Gulfport, Mississippi where the team was deployed days before Hurricane Katrina made landfall. Kissin left again, days after returning from the first trip, for Louisiana where he is currently participating in medical relief. Watch for a feature article

# US Postal Service and Maine Medical Center Hold Child Health Stamp Event

Earlier this month patients of the Barbara Bush Children's Hospital at Maine Medical Center helped introduce the new Child

Portland Postmaster Mike Fortunato presented an enlargement of the new Child Health stamp to MMC President and CEO Vince Conti. Meanwhile, children designed their own stamps on coloring pages and wrote postcards to friends and family. They affixed the new stamp to their postcards and

watched a postal clerk cancel it with a special Barbara Bush Children's Hospital postmark created just for the occasion. The kids, their families, and hospital staff then placed the postcards in a special "mailbox" for mailing later that day.

The same day, this postal operation moved to the hospital's Admitting Lobby so staff, patients, visitors, stamp collectors, and the general public could have an opportunity to purchase and use the new stamp with the special postmark. In all, 142 items were mailed, 1,340 stamps were purchased, and employees, families and patients had three hours of postage fun! The special postmark was available for 30 days for philatelists to use their usual procedure to obtain a cancelled special stamp.

detailing Kissin's experience with hurricane relief in a future issue of *What's Happening*.

MMC employees have been helping in other ways too. Similar to the September 11 and tsunami disasters, MMC has enabled employees to donate their earned time off to go toward disaster relief efforts through the Red Cross. So far, more than 350 employees have donated a portion of their paid time off. The Human Resources Department only

expects this number to continue to rise. MMC has also pledged \$25,000 to the VHA, which is a national association of nonprofit hospitals. VHA has set up a Relief Fund on behalf of hospital staff in the devastated area.

There have also been other employees who have gone to the Gulf Coast area as part of emergency efforts separate from MEMA. What's Happening will report on those stories in upcoming issues.

# New Laundry Facility to Debut in May

When noting the cuttingedge technology at Maine Medical Center, many highlight the frontline efforts, like the robotic surgical system that assists physicians performing prostate and heart surgery, or the new brachytherapy, an evolutionary radiation treatment for certain types of cancer. But what about the high-tech operations that are performed behind the scenes to support the day-to-day function of this leading hospital?

Beginning in May 2006, laundry from all Maine Medical Center locations will be processed at a new, hightech facility on Karen Drive in Westbrook, across from the Offsite Distribution Center. The new space occupies 23,000 square feet on 3.2 acres and nearly triples the space of the current laundry site in the basement of the Maine General Building.

This new facility will not only boost production, but also will save money in the long run—an estimated \$200,000 per year in production costs due to the conservation of energy and labor and the efficiency of the process. The technology that supports these savings is high-tech, mechanically operated, and highly automated.

The move to the new facility will also improve working conditions for staff as there will be more room to move around and less handson work. Instead of laundry being handled by staff eleven times throughout the processing of linen from the soiled to

Approved for 7.0 contact hours, the event is being planned with assistance from the Outreach Education Council at MMC. Nurses from all corners of the state are expected to attend.

Jens Eldrup-Jorgensen, MD, Director of the Division of Vascular Surgery at Maine Medical Center and the Medical Director of the Vascular Center will be the keynote speaker. He will also participate in a panel presentation with Dr. Robert Hawkins and Michael Tranfaglia, PA-C, entitled "Decisions in Patient Care: Clinical Case Studies." Also highlighting the agenda will be presentations by Melinda Zimmer-Rankin, MS, CCRN, University of Maine College of Nursing and Health Professions.

Planned for nurses, by nurses, the conference focus is specific to nursing care of the vascular patient. recall the very fundamental vision that guided our Board, medical staff, and senior management some seven years ago when we began putting together a long-term plan for the facilities of the Maine Medical Center and of the Barbara Bush Children's Hospital, the first phases of which we celebrate today.

"That vision was a deceptively simple one," Conticontinued, "to assure that our physical facilities are maintained and regularly and meaningfully renewed to meet patients' evolving clinical and human needs, and to do everything we can to have those facilities match and complement the exceptional skills of the physicians who practice here at Maine Med and of all our staff.

"Maine Medical Center is building on its strengths for a stronger community," Conti said. "People in Greater Portland and across Maine look to Maine Medical Center for a depth and breadth of services that simply cannot be found elsewhere in the state, and they are looking to us in increasing numbers. Along with the finest professionals and the latest equipment, the medical center must offer facilities that truly reflect a contemporary view of the nature of healing. Patients and families expect comfort as well as competence, privacy as well as pills, tenderness as well as technology."

In his remarks, Conti noted the efforts of Maine's Congressional delegation in Washington, which helped MMC secure \$1 million in federal appropriations from the Federal Department of Transportation to support streetscapes, roadways, and access around the new facilities. He recognized

Governor John Baldacci and Maine's legislators, and City of Portland officials for their diligence in reviewing our plans to best serve and care for people in southern Maine.

Conti also announced that the Hatch Pavilion name, which has been associated with MMC's birthing unit for the past two decades, will move to the second floor of the new women and infants building. The second floor will be the home of the family birthing center, newborn delivery, and operating rooms for c-sections.

"Many individuals, corporations and foundations have already made significant commitments to these projects, and employees and members of our medical staff have contributed at unprecedented levels," Conti said. "One extraordinary contribution was made very early in the campaign in honor of President and Mrs. Bush. MBNA has made a contribution of \$3 million, which is the largest single gift to this campaign, and the largest corporate contribution in the history of the hospital."

"This is the first milestone in the renewal of our facilities,

which will be constructed over the next two years," said Peter L. Haynes, Chairman of MMC's Board of Trustees. "Projects of this magnitude take leadership, input, and ideas from hundreds of people, including the patients and families cared for at Maine Medical Center and a team of extraordinary professionals who make it all come together."

"There will be many improvements made for patients in a number of important areas. An exciting part of this project is that we will greatly improve access to the hospital. Ease of getting around and knowing where to go will give people a very simple way to get to any point in the hospital from the new main entrance."

"In my work as a surgeon," said Hector Tarraza, MD, Chief of OB/GYN and Campaign Co-Chair, "I have the opportunity to see first hand the skills of our caregivers and to know how important knowledge, technology, research, and state-of-the-art facilities are to our caregivers and most importantly, our patients. clean stages, the new system will only require staff to handle the laundry twice. The layout of the facility will also restrict soiled laundry from traveling through the same area as clean laundry.

The new laundry site will process four-million pounds of laundry annually, but will have the capacity to handle eight-million pounds based on shift staffing. It will process materials from over 27 different sites, including the Bramhall, Brighton, Spring Harbor, Scarborough, and Falmouth campuses, with

the addition of more in the future.

How will the laundry be processed from each site? There will be a clean linen room for storage and there will be a staging area to keep soiled materials awaiting transport to the new laundry facility.

Once the laundry processing is transferred to Westbrook, old equipment will be removed from the laundry's current location and ways will be explored to best use the vacant space.

# 2006 Annual Open Enrollment
