

October 24, 1984 Wage, salary study is underway at MMC

A project to study Maine Medical Center's wage and salary administration program began last week. In a meeting with Department Heads and Supervisors October 17, and in a letter distributed to all employees October 18, president Edward C. Andrews, Jr., M.D., announced the study:

"This is one of the most important things we will do this year," he said. "The Medical Center's reputation for excellence in patient care and in service has been built by its employees. One of the keys to maintaining this reputation is our ability to recruit and keep highly qualified people. To do this, we must have a wage and salary program that is internally equitable and externally competitive."

Dr. Andrews said the study is meant to ensure that we are meeting these objectives. The salary for each position must be fair in relation to other jobs at Maine Medical Center and must be competitive with the salaries paid at similar institutions within the appropriate labor markets.

The study is not meant to be a cost containment measure, he said: "No one's current rate of pay will be cut as a result of this project, and no one's job will be eliminated as a result of this project."

The study will move through at least four major phases on its way to completion by April or May of 1985, and MMC employees will be directly involved along the way.

To help with the study, MMC has retained the services of The Sullivan Group, Inc., a personnel management consulting firm headquartered in Detroit. According to MMC Vice President for Employee Relations Ron Baril, the firm is well qualified and has conducted similar studies in over 100 institutions. "They have had a lot of hospital experience and worked with many large hospitals," he said. "They've already dealt with many of the issues we will be considering." Baril listed a number of institutions for which The Sullivan Group has conducted similar studies; included were Tufts-New England Medical Center and Johns Hopkins, Brigham and Women's, and Yale-New Haven hospitals.

The last hospital-wide review of MMC's pay program and pay policies was done in 1976. Sullivan Group representative Tim Cotter told people at last week's meeting that a pay system review should not be viewed as a great upheaval. "A lot has changed since MMC's review eight years ago: technology has changed, skills have changed, the markets have changed. A review of a pay system is an on-going process, and every organization should periodically review its wage and salary program."

MMC's Compensation Manager Margaret Boulos and her staff are coordinating the study and assisting everyone involved. Informational meetings, to accommodate all employees on all shifts, will be held to answer any questions employees might have about the study. Ms. Boulos also said she and STUDY, page 3

President for Risk Management Edward J. McGeachey.

Vice President for Nursing Judith T. Stone, RN, chaired the search that led to Ms. Taylor's appointment. "It's of interest to note that we conducted a national search, interviewing candidates from within Maine and as far away as Colorado," Ms. Stone said. "It was enthusiastically agreed that Pam Taylor possessed the attributes not only to lead Social Services, but also to integrate positively into the MMC community."

Before joining Mid-Maine Medical Center in 1980, Ms. Taylor was for two years Mental Health Supervisor of the Pleasant Point Reservation Health Center in Perry, Maine. She developed and implemented mental health and substance abuse services for that comprehensive community health center.

She has been the Chief Clinic Social Worker for the New Hampshire Division of Public Health Service Program on Alcohol and Drug Abuse, administering and supervising outpatient services in 19 communities and hospitals; and she has been Regional Director for the Lake Regional Office of Child and Family Services of New Hampshire in Laconia.

Ms. Taylor received her Master's Degree in Social Work in the area of casework from the University of Hawaii School of Social Work. She graduated from Colby College with a major in sociology.

The 1983-1984 president of the Maine Chapter, Society for Hospital Social Work Directors, she is the 1981-1984 chairperson of the Committee on Inquiry for the Maine Chapter, National Association of Social Workers, is a member of the Academy of Certified Social Workers, and is in the NASW Register of Clinical Social Workers.
