### **Employee benefits** improvements noted

The group health insurance plan for MMC employees was significantly enhanced, effective October 1, 1984. Employee Benefits Manager Don Sedenka explains the details:

"The type of coverage has been upgraded and although utilization has increased, MMC employees will not experience an increase in cost. This has been accomplished by: changing the major medical coverage from Unionmutual to Blue Alliance, developing a plan for self-insuring all our group health services filled within MMC, and by the Employee Benefits Office, in conjunction with the Health Promotion Program, assisting employees in the education of wellness and health care utilization. The emphasis this year will be on monitoring our costs closely and attempting to stabilize and perhaps decrease our group health utilization in order to keep future increases to MMC and its employees to a minimum.

"In addition, the costs for our Dental Assistance Program have increased due to utilization, however, this increased cost of the current program will be absorbed by the Medical Center.

"As of October 1 Maine Medical Center has upgraded its health insurance program to include Blue Shield 80% Usual, Customary and Reasonable (UCR) coverage and replaced Unionmutual (major medical) with Blue Alliance Mutual Insurance Company (BAMICO) for its major medical coverage. This increase in benefits will provide employees with better medical/surgical benefits. Previously, if an employee or covered dependents had surgery, a benefit was paid according to a "fixed fee" schedule. The maximum surgical allowance would have been \$1.850. ### United Way pace is looking real great

Officially, the United Way campaign within MMC is over, but it will be a while before we hear how well we did. At report time last week (September 26) we had raised \$28,697. That's 55 percent of our goal, with 46 percent of employees' cards turned in. That's also a terrific pace, boding well for the final tally.

The end of the campaign never means it's over, says chairman Mike Swan; there will be a predictable percentage of cards still out (for a variety of reasons) and pledges and donations will continue coming in for a time.

"It is time for me to say thank you," Swan says. "I really can't say enough for the people who've helped me with this

campaign; no one I've asked for help has hesitated to pitch in. People in Accounting, Administration, Audio/Visual, Cafeteria, Data Management, Public Information, Personnel, all have been great.

"The solicitors have been especially terrific. And Carol Cosand, who's cochaired the campaign, has given me a lot of support and a lot of her own time to the campaign," he said.

It won't be until all cards are accounted for and the books are really closed, that Swan will be able to hold the drawing for winners of the United Way incentive prizes. But here-in hopes of hurrying up some stragglers—is a rerun of the list of prizes for people and departments participating in the 1984 United

patient medical services, services of an anesthesiologist and emergency accident care rendered within 72 hours of an accidental injury when billed by a physician will be paid at 80% UCR. The 20% balance can be filled with major medical.

"If the physician's billed amount is above the UCR allowance and the physician has a Participating Agreement (has signed a Blue Shield contract), then the charge over the UCR allowance cannot be billed to the patient and the physician must write off the balance. This is an excellent benefit as it protects each employee from unlimited medical/surgical expenses.

"As previously mentioned, there has been a change in the major medical carrier effective October 1. The major medical contract will be with Blue Alliance Mutual Insurance Company (BAMICO) which is packaged together with Blue Cross and Blue Shield. The benefits are the same as previously held with a \$100 deductible; however the new family deductible coverage states that once two family members have met a deductible then other members can receive an 80% reimbursement, if applicable. The former coverage required a \$300 family deductible. If you have met your deductible, or any part of it, through the current Unionmutual Plan, it will be honored by Blue Alliance through December 31, 1984. There has also been an increase in the benefits regarding the maximum out-of-pocket expense. With the Unionmutual plan it was possible to incur \$3,500 in out-of-pocket expenses and with the new plan the total cost would be a maximum of \$500.

"The entire process of filing claims and coordinating Blue Cross/Blue Shield with Blue Alliance Major Medical will be facilitated under this new plan.

"Retirees of MMC enrolled in Companion Plan I as of October 1 are eligible to purchase Blue Alliance Mutual Insurance Company (BAMICO) Major Medical Benefits. This is a benefit that our retirees were previously not eligible for. It is an excellent benefit in that it cannot be purchased on an individual basis and offers the protection from catastrophic medical expenses for the retiree. The policy has a \$1,000,000 maximum benefit above Medicare's payment and Companion Plan I's benefits."

Within the next several weeks each employee in the group health insurance plan will receive new membership cards and a packet explaining the new plan and the claims process.

Workshops are in session this week to explain the new plan to employees and, if they wish, spouses. Remaining workshops are: today (Oct. 3) at 4 PM in Classroom 2; and Thursday, (Oct. 4) at 2 PM in Classroom 3. Additional workshops will be arranged if needed, Sedenka said.

NOTE: There will be an open enrollment period during the month of November for employees and their dependents. All employees eligible to participate in the group health plan who have not signed up may, from November 1 to November 30, 1984, enroll themselves and/or their dependents without providing evidence of insurability. If you wish to obtain coverage or modify your coverage, you must contact the Employee Benefits Office during the open enrollment period. This open enrollment occurs only once each year.

### Time to recertify Basic Life Support

Instructors and Instructor Trainers in Basic Life Support should note that it's recertification time in Cumberland County. A series of recertification programs, presented by the American Heart Association, Maine Affiliate, Inc., will be held this month and next:

# Unique gavel starts new MMC tradition

When the presidency of the MMC Medical Staff passed last month from Clement A. Hiebert, M.D., to F. Stephen Larned, M.D., so did a very special and symbolic gift. It is a gavel, newly made but with an incredible history. Dr. Hiebert himself made the gavel and presented it to Dr. Larned for all Medical Staff presidents to come. He also explained its origins:

- the wood for the handle came from an 8 x 8 inch spruce timber from the tower of the 1870 Building of Maine Medical Center
- the wood for the mallet head is from a grove of cherry trees near Philadelphia
- inside the ebony bung is a cavity containing a leaf fragment from the tree under which, by tradition, Hippocrates held forth on the Island of Kos (obtained for Dr. Hiebert by Professor Kurt Schmidt, Chairman of the Department of Anesthesia at Tufts University School of Medicine).

"The gavel represents a part of the birthplace of modern medicine, the birthplace of this country, and the birthplace of Maine Medical Center," Dr. Hiebert said. "I had fun making it and hope it will be both useful and symbolic for future presidents of the MMC Medical Staff."

On receiving the gavel, Dr. Larned said: "I know I speak for the entire staff in expressing appreciation and thanks to Dr. Hiebert for his thoughtfulness in conceiving, crafting, and offering this elegant, practical, and meaningful gift to the Medical Staff of the Maine Medical Center."
