# Staff appointments meet plan criteria

Twenty-five physicians have received appointments to the Medical Staff at Maine Medical Center. The appointments are the first to be made under the medical staff manpower plan mandated by the MMC Board of Trustees in May 1983.

At that time the Board voted that all applications for hospital staff privileges be subjected to explicit tests of hospital need in addition to the existing tests of physicians' qualifications, experience, and character.

"Hospital need is based on the need of the Medical Center's patients and is defined in the context of MMC's Mission Statement," Chairman of the Board James L. Moody explained then. The Statement says the hospital "will continue to be a community resource for (patients in) the Greater Portland area and a referral hospital for other areas of the state... The Center will allocate its resources for community and referral health care services within the scope of its resources and those available through other institutions and agencies in the community and state."

"The Trustees view the medical staff plan as an integral part of the hospital's general planning process," Moody said. "We are committed to a planning process designed to help Maine Medical Center achieve its basic objectives within the constraints of its available resources and consistent with the needs and resources of our community and State."

Pending development and implementation of the plan, the Board deferred action on all new applications for staff privileges for the period from July 1, 1983 to the effective date of the plan.

Planning began at the departmental level, with all clinical departments and divisions requested to project patient care priorities and make recommen-

# Dr. Hiebert elected to Harvard alumni post

Clement A. Hiebert, M.D., has been named President-Elect of the Harvard Medical Alumni Association. Dr. Hiebert, a Portland thoracic/cardiovascular surgeon, is President of the Medical Staff at Maine Medical Center. The Harvard Medical Alumni Association is composed of 7,000 Harvard Medical School alumni worldwide. As President-Elect, Dr. Hiebert will assume the Presidency of the Association in June, 1985.

He received postgraduate training at Massachusetts General Hospital, the Strangeways Research Laboratory in Cambridge, England, and at Frenchay Hospital in Bristol, England. He has been a member of the Harvard Alumni Council since 1980.

Dr. Hiebert has served as Director of the Surgical Clinics at Massachusetts General Hospital, Deputy Medical Director on the S.S. Hope, Assistant Clinical Professor of Medicine at Tufts University School of Medicine, and Interim Chief of Surgery at Maine Medical Center. dations. Staff planning was integrated with program planning and both were integrated with budget planning. The precise and exhaustive process resulted in a manpower plan that was adopted by the Board of Trustees in February 1984, after all departmental projections had been reviewed and approved by the Chief's Council, the Executive Committee of the Medical Staff, Administration, and the Joint Conference Committee.

"The plan in place is an effective and appropriate one," says Vice President for Health Affairs Costas T. Lambrew, M.D., "It gives the Medical Center the ability to modulate the growth of the Medical Staff and the direction in which that growth takes place, reflecting patient care needs and program priorities.

"It also give us, really for the first time, an objective assessment of our program needs enabling us to respond quickly and helpfully to physicians inquiring about the potential for practice here," Dr. Lambrew said.

In announcing the new Medical Staff appointments, Dr. Lambrew noted that the manpower plan will now be revised to reflect their presence as MMC considers applications received through the next year.

The types of the 25 new appointments, and the mix of specialties among those physicians with admitting privileges, reflect the effectiveness of the plan in preventing use of the resources of the hospital for one or a few procedures to the exclusion of other primary or tertiary problems needing care. Four appointments are to the Courtesy Staff. Of the 20 appointed to the Associate Attending Staff: six are pediatricians (including two replacements to salaried staff and two recruited for program purposes within their subspecialties); four are internists (including one recruited for program purposes); four are surgeons (including one recruited for program purposes); two are dentists; there is one obstetrician/ gynecologist, one radiologist (replacement), one family practitioner, and one psychiatrist. One Attending Staff appointment (pathology) is a replacement to the salaried staff.

"It should be emphasized that all department plans and projections upon which the manpower plan is based are dynamic and subject to review and change in response to patient care needs, practice developments, and the addition of new members to the Medical Staff." Dr. Lambrew said.

Still under study for integration into

the manpower plan are criteria for reappointment to the Medical Staff.
