#### MMC expansion nears end of review stage

The lengthy planning and approval process for Maine Medical Center's proposed expansion plans is nearing what should be the home stretch. The \$54.5 million project passed an important milestone July 27 when it received approval from the Maine Health Systems Agency. Final action by the Maine Commissioner of Human Services is hoped for by the end of September, and approval would signal the end of a process that has taken over five years -- as well as the beginning of a three-year period of construction and renovation.

The Certificate of Need application, which must be approved by the state

before construction can begin, is a large document -- about 2½ inches thick. With supporting documents the stack of paper approaches nine inches in height, but even at that size it belies the enormous effort that has gone into it. At every step of the way, that effort has involved physicians, nurses, support staff, administrators, trustees, and outside consultants.

MMC began investigating expansion prospects in 1976, and in 1979 began the long and complex task of developing a long-range master development plan for the hospital. It began with uncounted hours of meetings with individual departments, collecting information on present size, activities, and space needs, and estimating future **EXPANSION**, page 2

# Education helps keep diabetics healthy

The Diabetic Patient Education program at Maine Medical Center is in its eleventh year, and is approaching a milestone. According to Diabetes Nurse Specialist Georgette Carpenter, RN, BSN, the total attendance at the self-care classes will reach 20,000 before the end of this year. This number includes nearly 7,000 inpatients, over 6,000 private outpatients, and some 6,000 family members and clinic patients.

The classes, held daily during the week and open to all diabetics without charge, teach patients and family members how to cope with the disease. Each five-day session of two-hour classes covers basic knowledge of diabetes, urine testing, diet considerations, insulin and oral drugs, prevention of reactions and coma, and special areas such as dental care and pregnancy.

The MMC program was the first of its kind in Maine, and remains one of only two with ongoing, year-round sessions (the other is at Eastern Maine Medical Center in Bangor). Class members come from the inpatient units at MMC, private patients from the Greater Portland community, and from the MMC outpatient clinics. Mrs. Carpenter says that this kind of direct patient education is of paramount importance in managing diabetes, and most physicians recommend the classes to all their new diabetic patients.

Mrs. Carpenter says experience in Maine and elsewhere has shown that education keeps diabetics out of hospitals. "A complete understanding of the disease and what must be done to keep it under control," according to her, "is the best anti-hospitalization insurance there is." While it is hard to document a conclusive relationship, she points to a significant drop in **DIABETES**, page 4 Here at a glance are the highlights of the construction and renovation proposed at Maine Medical Center:

#### **NEW CONSTRUCTION**

• a four-story building adjacent to the rear of the Richards wing and connected to Richards by a nine-story elevator tower.

First Level central sterile supply area, blood bank, and mechanical services.

Second Level nineteen operating rooms (five more than present), an ambulatory surgical unit, and a recovery room.

*Third Level* special care and burn unit, operating room support services, and dialysis unit.

Fourth Level labor and delivery rooms and neonatal intensive care unit.

• three more levels on the parking ramp, adding 420 spaces.

#### RENOVATION

• a number of areas in the existing buildings will be renovated, such as those vacated by SCU, OR, and CSD. This will provide expanded and improved space for many departments.

At completion of the project, MMC will have an increase in licensed bed capacity from 533 to 598. Specifically, we would add:

40 medical/surgical beds a new total of 422

10 obstetrical beds a new total of 42


13 neonatal intensive beds a new total of 25

10 newborn bassinets
a new total of 40\*
2 intensive care beds
a new total of 46

(inc. SCU, CICU, and Burn)

\*not included in licensed bed count

More details about the new construction and renovation will be made available as decisions are made and approvals obtained.

needs. With that data and other information and input from trustees and government officials, MMC administrators and consultants compiled a Facilities Master Plan that projected the hospital's needs through 1990.

The long-range plan was accepted by the MMC Board of Trustees in mid-1981, and the Board gave the goahead for the detailed planning and drafting of Phase One of the plan later that year. The first phase addresses the most pressing needs as projected through 1985.

Employee input for the detailed planning was sought at the departmental level and in a series of over thirty special meetings called by Associate Vice President for Facilities Planning Reynold Welch. As he said at the time, "it is important to make sure that the people who spend so much of their time here understand the magnitude of the planning, and that they realize how seriously the institution is seeking their reactions and input."

That concern was taken to the community as well, with two neighborhood meetings held to discuss the proposed expansion. Concerns were allayed, questions answered, and suggestions obtained at those meetings, and the residents of the area surrounding MMC have been steady in their support of the expansion.

The Certificate of Need application was filed in March of this year, and over the past four months approvals have been obtained from the City of Portland's Zoning and Planning Boards, and from the Maine Department of Environmental Protection. Still to come is final action by Maine Human Services Commissioner Michael Petit, and next week *What's Happening* will examine the proposed timetable for final reviews, approvals, fundraising, and construction assuming a positive decision.

#### Lacombe named new Credit Union manager

diabetes admissions at MMC that corresponded with an increase in outpatient attendance at self-care classes.

The MMC classes are taught by Mrs. Carpenter, who has been educating diabetics most of her nursing career, and by Diabetes Nurse Specialist Debra Perkins, RN, BSN. Mrs. Carpenter and Mrs. Perkins are themselves diabetic, which they say allows them to serve as "living proof" for frightened new patients that diabetics can live normal lives. Dietary instruction is provided by MMC outpatient Dietician Jackie Merrill, RD. Medical advisor to the program is Norman Saunders, M.D.

Diabetics and their families are welcome to attend classes at any time. Staff and students at MMC are also welcome, and two hundred or so sit in on the classes each year. Mrs. Carpenter or Mrs. Perkins may be reached by radio page for more information.
