Rose Riordan, RN, Head Nurse on P3CD, has been named Nurse Coordinator for Risk Management, Vice President for Health Affairs Turner Bledsoe, M.D., announced this month. The extensive search to fill the new position lasted over a year, and Dr. Bledsoe says the search committee was "pleased to find in our own ranks the ideal person for the job."

Miss Riordan becomes the first nurse to assume staff responsibilities in Risk Management, although Nursing has had representatives on the Risk Management Committee for several years. The Nurse Coordinator will be responsible for the detailed investigation of unusual incidents in patient care, including injuries and problems with treatment. She will gather all appropriate facts and data from the staff involved as well as from the patient, and keep track of potential hazards.

The Nurse Coordinator also has an education role, in which she will use the knowledge gained in the investigation and analysis of risk areas to develop programs and policies to address particular problems. Miss Riordan will monitor all facets of patient care relating to risk management, and she will be a key participant in the process for improving effectiveness and safety of our care.

According to Dr. Bledsoe, a nurse brings to this position important clinical experience in hospital systems and an ability to deal effectively with both patients and staff. Associate Vice President for Risk Management Edward J. McGeachey says "Miss Riordan knows the hospital thoroughly, and she never hesitates to speak her beliefs," which makes her an excellent choice for this critically important position.

MMC discount program adds service station



Hospital has a tasty bonus for employees



Cystic Fibrosis test may be on the horizon

The National Cystic Fibrosis Foundation has awarded a \$32,841 grant to the Foundation for Blood Research in Scarborough, for the development of a blood test to identify carriers in Cystic Fibrosis.

Cystic Fibrosis (CF) is a genetic disease caused by a recessive gene, and is the most common recessive genetic disease in the Caucasian population. Carriers exhibit no symptoms of the disease, and at present the only way to identify them is by the birth of an affected child.

The CF gene is carried by one out of twenty whites, and when both parents are carriers the odds of producing an affected child are very high. CF is one of the few genetic diseases for which there is presently no prenatal screening technique, and eight to ten affected infants are born each year in Maine alone. A simple, reliable blood test would provide prospective parents with their risk information beforehand, if they wished.

The test will be developed by the FBR's Radioimmunoassay Laboratory, under the direction of Dr. George J. Knight. Other parts of the Foundation will be involved, as will consultants from specialized laboratories in Scotland.

1980 Annual Fund hits all-time high

The 1980 MMC Annual Fund closed its books with a record-setting total of \$152,252, according to Director of Development Peter C. Barnard. That amount is nearly \$24,000 more than was raised in 1979, and is well beyond the goal of \$140,000. The credit, Barnard says, goes to Mrs. Sidney W. Wernick, 1980 Annual Fund Chairman; to Mr. John W. L. White and Dr. Carlyle B. Voss, the Vice Chairmen; and to the conscientious members of the 1980 Annual Fund Committee, as well as the many hundreds of donors whose generous gifts made up the impressive total.

The 1980 contributors designated their gifts as follows: \$134,986 for Capital Purposes (building, renovation, and equipment); \$8,709 for Patient Care; \$2,332 for Medical Education; and \$6,225 for Medical Research. The fund will be spent on high-priority items that do not fit into the hospital's tightly-monitored budgets, or that occur between normal budgeting cycles.

The donors to the 1980 Annual Fund will be especially recognized by two "Appreciation Day Programs", one on the afternoon of Wednesday, April 29, and the other on Tuesday morning, May 5. All who contributed last year will receive invitations to these events. Program details on the Appreciation Days will be announced at a later date.

Show examines access to medical care in U.S.

As the United States continues to debate the pros and cons of a national health insurance program, a new awareness is growing: health care is not an unlimited resource. This means that the total deployment of life-saving resources -- what we have come to expect from medicine -- will not always be possible. How medical care is distributed in our society, and how well that distribution measures up to our ideal of justice, is examined in "Doctor, I Want. ...," the last of the six programs in the Hard Choices series being carried in Maine by MPBN's Channel 26.

The final episode of the series looks at the health care delivery system in America, the attitudes we have toward health care, and the definition of health itself. Willard Gaylin, M.D., President of the Hastings Center: The Institute of Society, Ethics, and the Life Sciences, hosts the program, scheduled for 11 PM Friday, February 6.

Almost ten percent of the country's Gross National Product, \$210 million each year, is spent on health care. Some argue that a national health care system would solve many of the economic and distribution problems, some that the only solution is a drastic change in lifestyles. "Doctor, I Want..." examines the ethical problems raised by a system which cannot meet all needs.
